Risk Statement

Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event



Inspections

The fact that race officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in this Notice of Race.

Declaration

The entry of the above boat is conditioned on acceptance of the following by the Owner/Competitor racing the boat:

1. The race organisers (including Teign Corinthian Yacht Club) shall not be liable for any loss, damage, death or personal injury howsoever caused to the Owner/Competitor as a result of taking part in the event. Moreover, every Owner/Competitor warrants the suitability of his/her boat for the event.
2. The provision of safety equipment and boats by Teign Corinthian Yacht Club neither guarantees that assistance can be rendered to any Competitor in need, nor an acceptance of any responsibility for the rescue of competitors. Further in the event that assistance is rendered to any Competitor, neither Teign Corinthian Yacht Club nor the crew of such rescue craft accepts liability for any loss, damage or injury to the Competitor and/or the boat and its equipment.
3. I declare that during the event I will hold a valid certificate of insurance including third party liability cover to a minimum of £2,000,000.
4. I agree to keep Teign Corinthian Yacht Club and its officers indemnified against all or any third party claims that may arise in connection with my boat and/or the users thereof.
5. I accept that the safety of the boat and her entire management, including insurance, shall be the sole and inescapable responsibility of the owner/competitor racing the boat.
6. I agree to be bound by the Racing Rules of Sailing and all other rules that govern this event. In particular, I confirm that I have read the Notice of Race and accept its provisions and agree that my boat will conform to the requirements set out in the Notice of Race throughout the event.
